Menu Neighborhood Agreement

1. This is an agreement between your business and Menu Neighborhood, for the purpose of posting information about your business at www.menuneighborhood.com.

2. We are responsible for posting menus received from your restaurant, classifieds received from your restaurant, and emailing those registered at menuneighborhood.com your menu specials. In addition, we will add any email addresses to the mailing list received directly from your restaurant.

3. You shall be responsible for sending menu copy, plus your specials and classified information, if you so choose.

Payment Options and Billing

4. Our service cost is **\$99 for 12 months**. Your menu(s) and classified information will be posted on our website, plus any menu specials emailed to patrons for 12 months. We will send you a renewal notice during the final month for the following 12 months. If payment is not received one week after the 12th month, your menu(s) and classifieds shall be removed from our website and patrons will stop receiving emails. We will reinstate your menu(s) and classifieds, plus restart the email list when payment is received.

Closing statements

5. We do not give your contact information or that of patrons to any other party, unless required by law to do so. This is kept on file at our office and viewed only by our employees.
6. If a menu is sent via pony express, it is returnable *upon request*. Any and all receipts from Menu Neighborhood shall be emailed to your restaurant.
7. Your restaurant **shall not** hold Menu Neighborhood responsible for lost, damaged or stolen menus, payment, or other correspondence, either sent electronically or by pony express.
